- (c) Relate the material facts relied on,
- (d) Specify the issues to be decided,
- (e) Refer to the statutory provisions relied on,
- (f) Set forth the reasons the appellant intends to rely on,
- (g) Indicate the relief sought, and
- (h) Date of notice.
